SUBJECT: Ambulance Purchase

## **REQUEST:**

City Council is requested to approve the purchase of one (1) Type III Class I Ambulance from Emergency Vehicles Plus, Holland, Michigan in the amount of \$149,897.00.

## **REASON FOR PURCHASE:**

The Fire Department currently operates five (5) ambulances providing medical transport services to City of Rochester Hills residents and visitors. The requested ambulance will replace the oldest front line ambulance bought in 2005, with a more reliable unit. Currently, the 2005 ambulance to be replaced has incurred increased repairs and maintenance costs resulting in significant downtime.

The replacement ambulance will improve the Fire Department's availability and efficiency to continuously handle five transports at one time and limit the requirement for mutual aid transport.

Request for Proposals were solicited and three closely priced and scored proposals were evaluated. Emergency Vehicles Plus, the sales center for Wheeled Coach, is the recommended company for award, based on best value, as well as excellent past experience with equipment and service. Overall, the Wheeled Coach warranty exceeds other proposers. Additionally, Emergency Vehicles Plus provides the most efficient production and delivery time.

Wheeled Coach Ambulance is one of the largest ambulance manufactures in the country. Emergency Vehicles Plus although located in Holland, Michigan, has a warranty service mechanic locally, who provides mobile service.

Award of this proposal will extend the pricing for the Wheeled Coach Type III Class I ambulance to the Michigan Intergovernmental Trade Network (MITN) cooperative under the same prices, terms and conditions.
