2008-0132 GSAB Property Nominations & Acquisitions Sub-Committee

Discussion commenced regarding the Harding Road nominated property. Mr. Mike Hartner, Director of Parks & Forestry summarized the grant process after Council accepts the GSAB recommendation and authorizes the Administration to begin negotiations with the land owner(s). The grant application deadline to the Michigan Department of Natural Resources (DNR) is August 1, 2008. However, land can be purchased outright with or without a grant or matching funds. The Harding Road property fits a very special criteria for trailways, wetlands, steep slopes, and natural features which the DNR allows extra points for eligible grant monies.
