#### **REQUEST:**

That the Rochester Hills City Council approves the Rights-Of-Way (ROW) acquisition for the Hamlin Road, (Livernois to Crooks) Project and authorizes payments to Sanzio Angeli in the amount of \$23,334.00 and Hamlin Development Associates Limited Partnership in the amount of \$82,952.00.

### **REASON FOR PURCHASE:**

On January 7, 2008, City Council approved a contract between the City of Rochester Hills and Hubbell, Roth & Clark, Inc. (HRC) to acquire ROW for the Hamlin Road (Crooks to Livernois) Project. HRC had been in the process of acquiring ROW and met a strict deadline to certify the ROW so MDOT could obligate the construction phase of the project. The construction phase was obligated by MDOT on August 22, 2008.

The only remaining parcel pending payment, not including those in condemnation, is H-14, Rae-Beck Holdings that is waiting for their mortgage company to sign the subordination form.
