SUBJECT: Energy Management System City Hall and Oakland County Sheriff's Office (OCSO)

### **REQUEST:**

The Building Department Facilities Division requests approval for the purchase of energy management systems for City Hall and Oakland County Sheriff's Office (OCSO) to K & S Ventures, Auburn Hills, Michigan in the amount of \$54,290.00 with a contingency of \$8,210.00 for a total not-to-exceed amount of \$62,500.00 and authorizes the Mayor to execute a contract on behalf of the City.

### **REASON FOR PURCHASE:**

The current energy management system at City Hall has passed its useful life and needs to be updated. It is difficult to use and is not currently providing the energy efficiency or operational control that can be gained by a more user friendly system. The current system is installed on a computer which (according to MIS) has also passed its useful and trusted life and the existing software cannot be transferred to another computer. The hard drives on these computers have a history of crashing after a few years and this one is well beyond those years. If the system were to crash, staff would have to revert to manual operation of the entire lighting and HVAC systems at City Hall.

The energy management system currently in place is a METASYS M3 Workstation and is proposed to be replaced with a FX-70-Supervisory Controller Tridium Software with open protocol interface web based interface so that any building can be accessed via the web. Further, it is anticipated that in the future other City buildings with other energy management systems can be linked via BacNet.

The City solicited Request for Proposals (RFP) on February 13, 2013. Two proposals were received and evaluated. K & S Ventures was selected as offering the best value, based on the proposed energy management system, meeting the requirements of the City. Product design, flexibility and operability, the experience and professionalism of the firm's personnel to perform the installation, calibration and references were considered.
