**SUBJECT:** Purchase Authorization for Natural Gas for City facilities

# **REQUEST:**

City Council authorization of a blanket purchase order to Consumers Energy, Lansing, Michigan, in the amount not-to-exceed \$200,000.00 for the purchase of natural gas for various City owned buildings through December 31, 2009.

### **REASON FOR PURCHASE:**

The members of the Michigan Intergovernmental Trade Network (MITN) cooperative group have worked with Michigan Municipal Risk Management Authority (MMRMA) and its partnership with Kimball Power Company to obtain professional assistance in selecting a reliable and cost effective natural gas provider. Consumers Energy currently remains the best value for the purchase of natural gas for the City. Therefore, the City desires to continue to contract for natural gas with Consumers Energy until an alternate provider of better value is identified. Estimates for 2009 for natural gas consumption by City facilities is \$200,000.00.

The City will continue to review the natural gas market to provide the best value.
