Construction Engineering Contract

REQUEST:

City Council is asked to approve the contract between the City of Rochester Hills and Orchard, Hiltz & McCliment, Inc. for construction engineering services for the reconstruction and widening work along Hamlin Road from Crooks Road to Livernois Road in an amount not to exceed \$999,781.17.

REASON FOR PURCHASE:

The City solicited Request for Qualifications Statements (RFQ) to provide construction engineering and testing services for the reconstruction of Hamlin Road, Crooks to Livernois Roads along with the construction of a roundabout at the Hamlin/Livernois intersection. A RFQ Review Committee was formed and Orchard, Hiltz & McCliment, Inc. was selected as the most qualified consultant to perform the services.

Orchard, Hiltz and McCliment, Inc. will provide full construction engineering services that include contract administration, inspection, staking, quality control testing and reporting, measurement, computation, and documentation of quantities, reporting and record keeping, and finalizing all project documentation performed by the contractor until completion and acceptance of the project by the City and the Michigan Department of Transportation (MDOT).

Orchard, Hiltz & McCliment, Inc. holds an approved status on MDOT's pre-qualified list for Road Construction Engineering and has working experience with FieldManager software and the MERL Program, both of which are MDOT requirements for federal aid funded projects.

Federal funds will cover 80% of the approved cost expenditures for the construction engineering services for the project. The City's share is 20%.

BUDGET:

The funds were included in the budget and the CIP as MR-02A. In the 2008 budget \$200,000 was included as the City's share of the construction engineering services and carried over to the 2009 budget. It was then determined that the City will pay 100% to OHM up front and be reimbursed 80% from MDOT. A 2009 first quarter budget amendment was approved for an additional \$800,000 bringing the total 2009 budget for construction engineering to \$1,000,000.
