


The Building Department has reviewed the amended site plan for the above address. The applicant has requested approval to use some of the existing adjacent exterior walkway for outdoor seating.

Please be advised that during the plan review process, it was determined by the Building Department that a fire suppression system was required in the exterior walkway area. As an alternate to the requirement for installation of the suppression system, the owner agreed that no combustible materials would be stored in that area, and signage would be posted throughout the area stating that combustibles could not be stored in that area. This agreement was implemented and the Fire Department was informed.

Therefore, if the exterior area is to be used for seating, all tables and chairs must be of a non-combustible material. Umbrellas, etc., are not to be used in the area, and the required signage must remain indicating combustibles are not to be stored in that area.

If this proposal moves forward, we will require the architect involved provide us the appropriate documentation for the tables and chairs indicating they are non-combustible. Such documents would them become part of the permanent record for Pei Wei.


