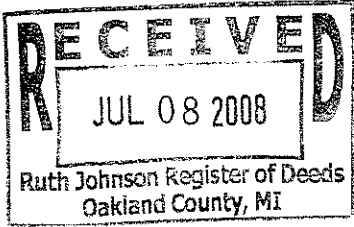

1. I am the Mayor of the City of Rochester Hills, which is the successor to the Township of Avon.


