SUBJECT:

Uninterrupted Power Supply (UPS) System Maintenance & Repair

REQUEST:

City Council is requested to authorize an increase to the existing blanket purchase order for the purchase of Uninterrupted Power Supply (UPS) Maintenance & Repair to Gruber Technical Inc, of Phoenix, AZ, in the increased amount of Fifteen Thousand (\$15,000) Dollars for a new not-to-exceed total of Forty Thousand (\$40,000) Dollars through April 12, 2012.

REASON FOR PURCHASE:

The City of Rochester Hills solicited proposals from qualified and experienced firms to provide UPS System Preventive Maintenance & Repair for the systems located at City Hall and the Communications Center.

Request for proposals were opened on January 22, 2009 an Evaluation Team reviewed the proposals and Gruber Technical Inc was selected to perform the services for a three (3) year term to expire on April 12, 2012.

The UPS batteries are required to be replaced every three years in order to provide adequate protection to the City's electronic equipment and to provide back-up power in the event of a power interruption. The replacement of batteries in two City systems resulted in additional labor and material costs and created a shortfall in the Blanket Purchase Order. At this time, an increase is requested in order to maintain the systems.
