This Agreement, made and entered into this	day of	, 2014,
by and between the Board of Road Commissioners for	the County of Oakland, I	Michigan,
hereinafter referred to as the BOARD, and the City of Roch	ester Hills, hereinafter refer	rred to as
the COMMUNITY, provides as follows:		

WHEREAS, the BOARD and the COMMUNITY have programmed the preliminary engineering for the future resurfacing of Tienken Road from Adams Road to Livernois Road, as described in Exhibit "A", attached hereto, and made a part hereof, which improvements involve roads under the jurisdiction of the BOARD, which improvements are hereinafter referred to as the DESIGN; and

WHEREAS, the estimated total cost of the DESIGN is \$384,000; and

WHEREAS, the parties hereto have reached a mutual understanding regarding the cost sharing of the DESIGN and wish to commit that understanding to writing in this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants set forth herein and in conformity with applicable law, it is hereby agreed between the COMMUNITY and the BOARD that:

- The COMMUNITY approves of the DESIGN, declares its public necessity, and authorizes the BOARD to perform or cause to be performed, and complete the DESIGN along with all administration in reference thereto.
- 2. The DESIGN shall include preliminary engineering.
- 3. The estimated total DESIGN cost of \$384,000 shall be shared equally by the BOARD and the COMMUNITY. Each 50% share is estimated to be \$192,000,

respectively. The COMMUNITY also agrees that any cost overages will be funded equally by the BOARD and the COMMUNITY.

- 4. Upon execution of this Agreement, the BOARD shall submit an invoice to the COMMUNITY for \$96,000 (being 50% of the COMMUNITY'S share of the estimated total DESIGN cost).
- 5. As costs of the DESIGN are incurred, the BOARD shall invoice the COMMUNITY for the remaining 50% of the COMMUNITY'S total contribution.
- 6. Upon receipt of said invoices, the COMMUNITY shall pay to the BOARD the full amount thereof, within thirty (30) days of such receipt.
