**SUBJECT:** Weed Mowing/Lawn Maintenance for Ordinance Compliance

## **REQUEST:**

City Council is requested to authorize a blanket purchase order for weed mowing and lawn maintenance for Ordinance compliance to D & W Services, LLC, Ortonville, Michigan in the amount not-to-exceed \$65,000.00 through December 31, 2010.

# **REASON FOR PURCHASE:**

City Ordinance Section 84-17 – Weed Control requires owners and occupants of land to cut or destroy all noxious weeds growing on the property. In the event the property owner fails to maintain the property and heed warnings from the Ordinance Compliance staff, the City is allowed to enter upon the property to cut grass and weeds.

Request for Proposals for weed mowing of unoccupied lots were solicited and evaluated by Ordinance Compliance Staff of the Building Department and Purchasing with award recommended to D & W Services LLC, Ortonville, Michigan based on best value to the City in terms of quality of work, experience, capacity of contractor, caliber and quantity of equipment and cost proposal

In 2009, the City awarded a contract to D & W Services, LLC for mowing of non-compliant occupied properties. These services require good judgment on the part of the contractor, attention to details and close coordination with Ordinance Enforcement Staff. Besides mowing, the contractor is responsible for identification of violations and providing documentation, including measurements and photographs.

Based on the quality of the collaborative efforts of the contractor, the City recommends award of both the non-occupied and occupied properties weed mowing contracts to D & W Services LLC, Ortonville, Michigan. Combining the two contracts, utilizing one contractor, will assist Ordinance Compliance staff in their efforts to effectively and efficiently maintain properties and protect the health, safety and welfare of City residents. The new contract is approximately a 10% savings over the prior contractor.

The costs for these services are billed to the property owner or ultimately added to property taxes.
