**SUBJECT:** Janitorial Services

### **REQUEST:**

City Council is requested to increase the blanket purchase order for janitorial services for Thundermop Maintenance Company, Hartland, Michigan in the amount of \$10,000.00 for a new not-to-exceed amount of \$200,800.00 through October 1, 2012.

### **REASON FOR PURCHASE:**

Thundermop Maintenance Company is the current provider of janitorial services for City Hall and the DPS/Garage. With the award of a new janitorial contract to Du All Cleaning Inc., the City is working on the transition to a new company and acclimation of staffing with City personnel and job duties.

Thundermop Maintenance Company will continue to provide services until September 1, 2012 to facilitate the transition. The 2-year blanket purchase order approved by City Council in 2010 in the amount of \$200,800.00 through June 1, 2012 requires an increase in the amount of \$10,000.00 to cover the estimated cost of two additional months of janitorial services.
