SUBJECT:	Supplemental Accident and Sickness Insurance for Fire Fighters

# **REQUEST:**

Authorization of a blanket purchase is requested for a three-year renewal of the Accident and Sickness Insurance policy with Volunteer Fireman's Insurance Service (VFIS) in an amount totaling \$73,647, to provide supplemental insurance coverage in the line of duty for career and paid-on-call (POC) fire fighters, effective July 1, 2012.

### **REASON FOR PURCHASE:**

Under the terms of the current contract with Local 3472 of the International Association of Fire Fighters, the City of Rochester Hills funds the full cost of accident and sickness insurance for fire fighters injured or killed in the line of duty. The policy renewal will cover 32 career and 80 POC fire fighters.

A request for proposals was issued based on a June 30 policy expiration date. A side-by-side comparison of the two responses received is attached. They reflect generally comparable benefit levels in the major coverage areas, including loss of life, lump sum living, weekly income and medical expense benefits.

The renewal quote from VFIS reflects an annual increase of \$1,755 (7.6%). Although no coverage improvements were offered with this renewal, improvements in plan design and medical expense benefits were associated with the prior renewal, along with a \$3,944 reduction in premium at that time. The current quote is still \$2,189 less than the annual premium prior to 2009.

The recommendation to renew with VFIS is value-based. VFIS has provided coverage to the City for over 25 years. The Fire Department has expressed satisfaction with their customer service, including over \$60,000 on 14 claims processed in the past two policy periods. In addition, they provide other value-added features, such as training materials available free of charge to insured agencies.

Finally, the union contract currently provides for a carrier change with union concurrence. Given the level of satisfaction on behalf of both Fire administration and union employees, a carrier change based solely on the price difference between the two quotes is not supportable.

It is recommended that City Council approve a three-year renewal of Accident and Sickness Insurance policy with Volunteer Fireman's Insurance Service (VFIS) in the amount of \$24,549 per year, for a total of \$73,647, to provide supplemental insurance coverage for career and paid-on-call (POC) fire fighters while in the line of duty, with a policy term of July 1, 2012 through June 30, 2015.
