# Text of Legislative File 2010-0108

### **Title**

Request for Historic District Designation - William S. Adams House, 2040 S. Livernois, located on the southwest corner of Livernois and Hamlin Roads, Zoned R-2, One Family Residential

#### Body

**Whereas**, Division 4 of the City's Historic Preservation Ordinance (Chapter 118) establishes the procedure for the establishment, modification or elimination of Historic Districts; and

Whereas, Section 118-130 of the City's Historic Preservation Ordinance (Chapter 118) identifies the duties of the City's Historic Districts Study Committee and the process for establishment of a study committee report; and

Whereas, the City's duly established Potential List included the following property, identified as:

2040 S. Livernois Road, Parcel Number 15-28-226-026

Whereas, in compliance with the City's Historic Preservation Ordinance, the City's Historic Districts Study Committee conducted research on the above identified property; prepared a Preliminary Report in March of 2009; transmitted a copy of the Preliminary Report to the City's Planning Commission and the State Historic Preservation Office; held the required and properly noticed Public Hearing on February 11, 2010; and submitted a Final Report to City Council; and

**Whereas**, based on the distinctive characteristics of a type and style of architecture (period of significance is ca. 1835-50) when the house was built, it is the recommendation of the Historic Districts Study Committee that City Council designate the property and establish the site as a Local Historic District within the City of Rochester Hills.

**Resolved**, that the City of Rochester Hills City Council concurs with the recommendation of the City's Historic Districts Study Committee and does hereby designate the property identified above as a local Historic District within the City of Rochester Hills, and requests that the City Attorney prepare the appropriate Ordinance Amendment to the City's Historic Preservation Ordinance (Chapter 118).
