

ORDINANCE NO.

AN ORDINANCE TO AMEND CHAPTER 138, ZONING, OF THE CODE OF ORDINANCES OF THE CITY OF ROCHESTER HILLS, OAKLAND COUNTY, MICHIGAN, TO REZONE THE PROPERTY DESCRIBED HEREIN FROM R-4 (ONE FAMILY RESIDENTIAL) TO SP (SPECIAL PURPOSE) AND TO PRESCRIBE PENALTIES FOR THE VIOLATION THEREOF (3.28± acres).

THE CITY OF ROCHESTER HILLS ORDAINS:

Section 1. The zoning classification of the following described property shall be amended as follows:

3.28± acres zoned **from** R-4 (One Family Residential) **to** SP (Special Purpose)

SITE DESCRIPTION:

Land in the City of Rochester Hills, Oakland County, Michigan, described as:

Lots 105, 106, 107, 108, 109 and part of Lot 114 of “Sunnydale Gardens No. 2” as recorded in Liber 64 of Plats, Page 19, Oakland County records, **EXCEPT:** All that part of said Lot 114 lying south of the easterly extension of the south line of said lot 109 of said “Sunnydale Gardens No. 2,” being part of the West ½ of the West ½ of Section 33, T3N, R11E.

Commonly known as: N/A

Parcel Identification Nos. 15-33-351-003, -004, -005, -006, -007 and part of -019

Section 2. **Section 3.01.** Boundaries, and the Zoning Map attached to the Zoning Ordinance, shall be amended to depict the amendment to the zoning classification for the property described herein (3.28± acres) from R-4 (One Family Residential) to SP (Special Purpose).

Section 3. **Severability.** This Ordinance and each article, section, subsection, paragraph, part provision, sentence, word and any portion thereof are hereby declared to be severable, and if they or any of them are declared to be invalid or unenforceable for any reason by a court of competent jurisdiction, it is hereby provided that the remainder of this Ordinance shall not be affected thereby.

Section 4. **Penalty.** All violations of this ordinance shall be municipal civil infractions and upon a determination of responsibility therefor shall be punishable by a civil fine of not more than \$500.

Section 5. **Repeal, Effective Date and Adoption.**
