SUBJECT: HVAC Renovations at Fire Station #1

REQUEST:

City Council is requested to authorize a project budget for the renovation of the HVAC system at Fire Station #1 in the amount of \$285,000.00 to North Star Mechanical, Inc., Shelby Township, Michigan and other contractors as required to complete the project.

REASON FOR PURCHASE:

Request for Proposals were solicited, received and evaluated with North Star Mechanical, Inc. recommended by the evaluation committee for award of the contract to perform renovations to the HVAC system at Fire Station #1, as providing the best value for the City.

Fire Station #1 was built in 1984, followed by two (2) subsequent additions. The building housed both the Rochester Hills Fire Department and the Oakland County Sheriff Substation until approximately 2003. Currently, the building is used for Fire Department Administration, 24-hour fire and emergency services and 24-hour dispatch. Repairs and maintenance to the current system have been extensive, while the inability to stabilize the temperature throughout the building has remained inadequate. As the building is 365/24/7, climate control is essential for personnel both working and sleeping and technology stability.

The project will discontinue the use of the existing 15-ton chiller, air handler and hot water boiler and create seven (7) single zone forced air constant volume heating and cooling zones. Construction will be phased to provide minimal disruption to Fire Department operations. The new system, that includes an Energy Management System, will produce energy efficiencies including reduction in utility costs and long term overall savings in maintenance costs.
