## **PUBLIC COMMENT**

Mr. Lee Zendel, 1575 Dutton Road, indicated what he characterized as several misquotes in a recent Detroit News article regarding the rumor that the City may close some of its parks. He then referenced a Wall Street Journal article that noted the increase in satellite dish subscriptions, thus threatening the amount of revenue the City receives from cable television franchise fees. Mr. Zendel noted that, although the Mayor stressed in her recent State of the City address that increased community growth creates a greater demand for police and fire services, "the administration has failed to add at least one deputy per year, which once was the policy."

Ms. Barbara Zimmerman, 1321 East Horseshoe Boulevard, noting she is a sixteen-year resident of Rochester Hills, described a problem she has been experiencing for several years wherein her neighbor's sump pump causes flooding on her property. She noted that she has worked with the City's Engineering Department and they have tried to address the problem, however, she is to the point where a civil suit against her neighbor may be necessary.

President Hill noted that the City has ordinances that should address this situation and that all subdivisions have approved site plans to ensure that this type of situation does not occur. She recommended that Ms. Zimmerman speak to Mr. Ed Anzek, Director of Planning/Development.

Ms. Lois Golden, 645 Apple Hill Lane, called on the Council to improve communication regarding the Adams Road/M-59 interchange project.

#### LEGISLATIVE & ADMINISTRATIVE COMMENTS

President Hill offered the condolences of the Mayor and City Council to the family of William Thurston, a long-time City employee who passed away while plowing the City streets. She announced that there would be a lecture on March 8th regarding the natural features inventory portion of the Master Land Use Plan update. She also noted that the Clinton River Watershed would be hosting training workshops for its Adopt a Stream Program on March 5th and March 10th. Finally, she stated that the Oakland Land Conservancy would be holding its annual meeting on March 14th at the Southfield Library.

Ms. Holder indicated that there were flyers at the back of the auditorium regarding the Vegas Night fundraiser for the Muscular Dystrophy Association and advised interested parties to call 586-274-9000 for more information.

Mr. Barnett praised the City's Fire Department for their quick response to a fire at his residence on Monday. He then noted that a Rochester Hills resident had been killed while serving in the military in Iraq. Mr. Barnett expressed his condolences to the soldier's family and his appreciate for his service and sacrifice.

Ms. Raschke noted that she is "very saddened" that a department director was responsible for the rumor regarding possible closure of City parks. She expressed her hope that there is a policy prohibiting this type of thing from occurring again.

Mr. Dan Casey, Economic Development Manager, noted that this is one of the many steps in the process of amending the boundaries of the LDFA and drafting a different plan for the City's SmartZone. He stressed the "tight time frame" of the entire process.

A motion was made by Robbins, seconded by Dalton, that this matter be Adopted by Resolution.

Whereas, Public Act 281 of 1986 is an act to prevent urban deterioration and encourage economic development including, but not limited to, high-technology industries and activity and to encourage neighborhood revitalization and historic preservation and to provide a mechanism for developing and implementing plans within a development area; and

Whereas, the City of Rochester Hills and Michigan Economic Development Corporation have entered into an agreement that establishes the boundaries of a certified technology park within the City of Rochester Hills; and

Whereas, the Rochester Hills Local Development Finance Authority was established On May 4, 1994; and a Development Plan and Tax Increment Financing Plan, "the Plan", were approved by City Council on May 3, 1995; and

Whereas, the Plan was amended and adopted by the City Council on July 15, 1998; and

Whereas, the board of a Local Development Finance Authority may amend a development plan and financing plan, pursuant to Public Act 281 of 1986, as amended, Section 17 [MCL 125.2167].

Council members expressed their desire to open the job posting to all City employees while acknowledging that the qualifications will likely eliminate all but the two known interested parties.

**Ms. Pam Lee**, Director of Human Resources, noted that the City Council has a great deal of leeway in determining their appointment process, including setting stipulations requiring any certifications for successful appointees.

It was noted that following an evaluation of internal candidates, City Council may determine that an external search is warranted.

**Ms. Lee** indicated that she would post the position internally for a five-day period beginning Monday, March 7th.

**President Hill** explained that Council would examine the 2005 budget goals to make a determination of what would be discussed at the upcoming budget work session on March 9th.

Mr. Ed Anzek, Director of Planning/Development, provided the list of eight goals Council

determined were priorities during the budget process the previous year:

#### Goals for 2005

- \* Improve Economic Development
- \* Enhance/Maintain Infrastructure
- \* Enhance Quality of Life
- \* Enhance Communication with Residents
- \* Improve Technology
- \* Enhance/Maintain Public Safety Levels
- \* Efficient Government
- \* Maintain Financial Stability

Council members stressed that all of these goals were still worthy of pursuit and that, in most cases, were so broad in nature that they would likely be ongoing indefinitely. **Mr. Barnett** indicated that these were the goals of any community.

It was determined that the specific long- and short-term objectives for reaching these goals were what would need to be prioritized at the next budget work session.

Mr. Anzek explained that the process is for Council to prioritize their objectives, then staff meets to discuss the specific techniques for tackling these objectives and refining the list.

Request that Council Member Pagers Receive Emergency Response Calls

**Ms. Raschke** requested that the City Administration provide Council members with the option of being paged for all high priority Fire Department emergency calls. She noted that, as Chairperson of the Public Safety Committee, she believes Council members should "be aware of what's going on in the community as far as call volume."

**Mr. Robbins** stated that he has had this service on his City pager since the Public Safety Committee was formed and it does not result in an added expense to the City or a need for a different pager than Council members already use.

**Mr. Dalton** further noted that the information requested is available to the general public through the use of inexpensive scanners.
