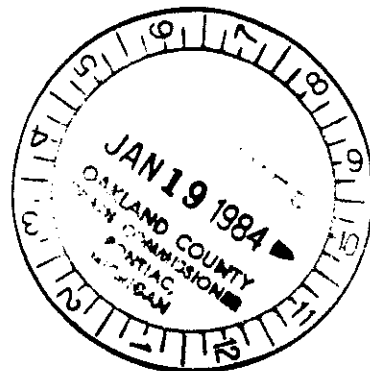


P E T I T I O N



TO THE DRAINAGE BOARD FOR THE
HEREINAFTER MENTIONED OAKLAND
COUNTY, MICHIGAN DRAIN PROJECT

The undersigned public corporation hereby petitions
for the location, establishment and construction of an
intra-county drain to be located approximately as follows:

Beginning at a point in the Honeywell Drain approximately 980 feet South of the N.E. Section corner of Section 24, T. 3 N., R. 11 E., Avon Township, Oakland County, Michigan; Thence Northwesterly approximately 60 feet to a point "A"; Thence Northwesterly approximately 530 feet; Thence Westerly approximately 90 feet; Thence Northwesterly approximately 335 feet; Thence Westerly approximately 80 feet; Thence South Southwesterly approximately 175 feet; Thence Southwesterly approximately 130 feet; Thence Westerly approximately 400 feet; Thence Southwesterly approximately 835 feet to a point "B" being the intersection of the Honeywell Drain and the Honeywell Drain extension; Thence Southwesterly approximately 215 feet; Thence West Southwesterly approximately 340 feet; Thence Southwesterly approximately 420 feet to a point "C"; Thence South Southwesterly approximately 1,280 feet to the intersection of the Honeywell Drain and the East and West 1/4 line (School Road) being approximately 770 feet West of the center section; Thence Southwesterly approximately 1,400 feet; Thence West Southwesterly approximately 410 feet; Thence Southwesterly approximately 470 feet; Thence South Southwesterly approximately 355 feet; Thence Westerly approximately 260 feet to the intersection of the Honeywell Drain and the West section line of Section 24 (John R Road) being approximately 970 feet North of the S.W. section corner of Section 24; Thence West approximately 80 feet to a point "D"; Thence Southerly approximately 230 feet; Thence Westerly approximately 1,210 feet; Thence Northerly approximately 300 feet; Thence Westerly approximately 1,150 feet to a point "E" being the intersection of the Honeywell Drain and its branches Number 1 and Number 2; Thence Westerly approximately 140 feet; Thence North Westerly approximately 1,165 feet; Thence Westerly approximately 750 feet; Thence West Northwesterly approximately 410 feet; Thence North Westerly approximately 545 feet; Thence Westerly approximately 100 feet to the intersection of the Honeywell Branch Number 2 and the West section line of Section 23 (Rochester Road) being approximately 1,675 feet North of the S.W. section corner of Section 23; Thence Northwesterly approximately 100 feet to the existing Winchester Village Number 1 detention pond and the point of ending.

Also beginning at point "D"; Thence Westerly approximately 110 feet; Thence Northwesterly approximately 2,125 feet to the East and West line of Section 23, being approximately 1,150 feet West of the East 1/4 corner of Section 23; Thence Northwesterly approximately 150 feet; Thence Northerly approximately 280 feet; Thence Westerly approximately 750 feet; Thence Southerly approximately 230 feet; Thence Westerly approximately 500 feet; Thence Northerly approximately 205 feet; Thence Westerly approximately 275 feet to the point of ending.

Also beginning at point "E"; Thence North Northwesterly approximately 370 feet; Thence Northerly approximately 300 feet; Thence Westerly approximately 395 feet; Thence West Northwesterly approximately 450 feet; Thence North Westerly approximately 535 feet; Thence Northwest-erly approximately 400 feet; Thence Northerly approximately 100 feet to the East and West 1/4 line of Section 23, being approximately 1,400 feet East of the West section corner of Section 23; Thence Northerly approximately 50 feet; Thence West Northwesterly approximately 310 feet; Thence Northwesterly approximately 410 feet; Thence North Northwesterly approximately 160 feet; Thence Northerly approximately 150 feet; Thence North Northwesterly approximately 240 feet to the point of ending.

Also beginning at point "B"; Thence Northwesterly approximately 350 feet; Thence North Northwesterly approximately 570 feet to the North section line of Section 24, approximately 180 feet East of the North 1/4 corner of Section 24; Thence North Northwesterly approximately 960 feet; Thence Northwesterly approximately 1,600 feet; Thence West Southwesterly approximately 680 feet to the West section line of Section 13; Thence Westerly approximately 2,800 feet to the East line of Heatherwood Subdivision and the point of ending.

Also a retention area to service the above mentioned routes and constructed between point "A" and point "C".

which drain is necessary for the public health, is located entirely within the limits of the Charter Township of Avon and will carry drainage water originating in the County of Oakland only.

This petition is filed pursuant to the provisions of Chapter 20 of Act No. 40 of the Public Acts of 1956, as amended.

The undersigned public corporation hereby consents to the location of the foregoing described intra-county drain project entirely within its limits.

It is understood that the entire cost of said project is to be assessed against this petitioner except for assessments against the County of Oakland and the State of Michigan on account of drainage of county and state highways, if any.

A certified copy of the resolution of the governing body of the Charter Township of Avon authorizing execution of this petition is hereto attached.
