SUBJECT: Tractor-Loader-Backhoe for Parks & Forestry Department

REQUEST:

City Council is requested to authorize the purchase of one (1) new John Deere 4320 Tractor, 400CX Loader, and RB2307 Backhoe utilizing the State of Michigan MiDeal Extended Purchase program in the amount of \$37,264.13; John Deere Company, 2000 John Deere Run, Cary, NC.

REASON FOR PURCHASE:

The City purchases John Deere equipment through the State of Michigan MiDeal Extended Purchase Program. Equipment purchased through this program is at a cost significantly lower than retail. The discount received by utilizing the State of Michigan contract for the 4320 Tractor and RB2307 Backhoe is 17% and the 400CX Loader is 21%.

The Parks and Forestry Department utilizes Tractor Loader Backhoes for numerous maintenance and construction tasks such as loading and unloading bulk and palletized materials, grading roads, pathways, parking lots, infields and warning tracks, rototilling, heavy mowing, aerating, topdressing, fertilizing and over-seeding, excavating for irrigation and drainage construction.

Based on estimated utilization, the new Tractor Loader Backhoe is anticipated to have a 10 year life cycle. The 2002 John Deere Tractor Loader Backhoe currently in use will be relocated from Borden Park for use at the Museum. The Fleet Division is responsible for maintenance and repairs for both pieces of equipment.
