Deer Management Advisory Committee Recommendations for 2011

- B. Meetings

We took minutes for all these meetings and they were made available on the city's website. Our general course of action is to continue with the plan that we laid out last September with some additional recommendations. That course of action is to continue with non lethal means of control with respect to the deer population. The plan should be re-evaluated every May when the new numbers become available on the deer/vehicle collisions as documented by SEMCOG. This is one of the 2 benchmarks recommended by the DMAC. The second benchmark is the annual aerial survey of the deer population. No further action is recommended as long as the deer/vehicle collisions are less than 200 for the year and the deer population does not go over 20% from the previous year. This year the deer population rose but the deer/vehicle collisions went down. The number of deer/vehicle collisions was 165 for 2009 compared to 168 for 2008. The deer count in the aerial survey rose by 34% from 80 deer sighted in 2009 to 107 sighted in 2010. These sightings occurred in the same 5 areas viewed in previous years. The average number of deer sighted during all the aerial surveys is 164 so this year's sightings although up from 2009 are still considerably below average. We the DMAC believe that the city should continue to monitor these deer population trends with aerial flyover data and SEMCOG car/deer collision data while fully implementing the educational component and the improved signage and roadside deterrents. I will present a summary of our recommendations at the City Council meeting on November 22nd.

C. Aerial Survey of Deer conducted on February 11th of 2010

The 5 historical areas included in the aerial survey:

- 1. Riverbend Park (115 acres)
- 2. City Hall (138 acres)
- 3. Bloomer Park (267 acres)
- 4. Winkler Mill (109 acres)
- 5. Butler Rod (330 acres)

The aerial surveys have now been expanded to a total of 10 areas. The survey in the appendix shows all 10 areas. The DMAC would like to thank the Administration for providing the information in the appendix which we found to be most helpful. **DMAC** recommends that a total of \$1100 be set aside from this year's DMAC budget and reimburse the Parks and Recreation dept for this flyover aerial survey expense. We focused on the original 5 areas since those are the areas studied in the past for reference purposes.

E. Feeding Ban Ordinance

- 1. Continue the ban on feeding wildlife (with exception of birds)
- 2. Increase the number of public reminders to residents to ensure awareness of the ordinance
- 3. Strongly enforce the ordinance to ensure compliance.

F. Educational Component

- 1. Target educational focus during months of September through December and during peak hours of dawn and dusk.
- 2. Designate October as "Deer Awareness Month"
- 3. Offer more homeowners tactics, and programs on dealing with the city's deer population.
- 4. Have Parks & Forestry Dept. report in May 2011 on the status of the educational components, aerial flyover results, and SEMCOG's deer /vehicle crash data.
- 5. Provide updated deer information on the city's website and cable station and add a link to SEMCOG's "Don't Veer for Deer" program.
- 6. Keep logs of deer calls/complaints for inclusion in future reports

G. Improved Signage

- 1. Identify major road areas where high growth brush clearing would help increase deer visibility and notify property owners with recommendations.
- 2. Identify and publicize high deer/vehicle crash areas.
- 4. Encourage Oakland University to continue with their wonderful program of clearing brush along the high deer/vehicle crash areas adjacent to their property along Adams and Avon Roads. We want to thank the Administration for making great inroads in this area.
- 5. Through a Federal grant speed signs will be soon added to all the school districts to remind motorists of their speeds. We believe this is a great idea that may have a collateral benefit to our program of trying to reduce the number of deer/car collisions. The DMAC would like to recommend to City Council to allocate the remaining money in the budget for DMAC this year to order 2 of these speed warning signs to be installed in a high deer/vehicle collision area, independent to any school district.

H. Continue Ban on Bow Hunting

- 1. Invited the DNR to visit us at our June meeting to explain what bow hunting would look like if Rochester Hills ever lifted its ban on hunting within the city.
- 2. Officer Ben Shively pointed out the different hunting laws that exist under the DNR's control.
 - a. A hunter cannot trespass onto another's property to claim a killed deer without the homeowner's permission.
 - b. If a homeowner does not give permission, the deer will stay where it lies. Neither the homeowner nor the hunter will be able to move the carcass.
 - c. Hunters as young as 10 will be able to hunt while accompanied by an adult.
 - d. It's a fact that bow hunting will not deliver as sure a kill as a rifle shot, so there will probably be more wounded animals than during rifle season.
- 3. For the above mentioned reasons and there were others, the committee reached consensus that bow hunting of any variety probably is not viable in a city like Rochester Hills.
- I. Immuno-Contraceptives are not recommended at this time.

 I verified with the DNR that at present they still have not approved any substance in Michigan to be used as an immune-contraceptive on deer. I received a policy letter from Russ Mason, the Chief of Wildlife division last year stating the DNR's policy regarding this issue and it has not changed at present.

J. DMAC for Next Year?

I believe that our terms on DMAC are expiring at the end of this month. We the committee serves at the pleasure of City Council. We have enjoyed our journey trying to find solutions to reducing deer/vehicle collisions and reducing nuisance complaints. We believe we have made a substantial contribution, but more needs to be done. We currently have 7 citizen members, and I believe that at least 4 of those are interested in returning to the DMAC if Council so desires.

The next 3 pages are part of the <u>appendix</u> giving more details on the aerial survey including 5 additional areas, more information on the deer/vehicle collisions, and a summary of citizen complaints for this year. The DMAC would like the Administration, particularly Mike Hartner and Lance DeVoe for collecting this information. The DMAC found it to be extremely helpful.


Oakland County conducted their annual aerial deer survey in Rochester Hills on February 11, 2010, using the same flight crew and equipment as in the last three year. The raw numbers for 2009 and 2010 and percent of change are as follows:
