SUBJECT: Janitorial Supplies & Products

REQUEST:

City Council is requested to authorize the issuance of a blanket purchase order for janitorial supplies, paper products, green cleaning products, and other items to Imperial Dade/Nichols Paper & Supply Co., Rochester Hills, MI 48309, in the total amount not-to-exceed \$80,000.00 through May 31, 2025.

REASON FOR PURCHASE:

The City of Rochester Hills requires the purchase of janitorial supplies, paper products, green cleaning supplies, cleaning equipment and other items for City Hall, Fire Stations, DPS Garage, Van Hoosen Museum, Borden, Bloomer and Spencer Park locations that must be delivered minimally once per month and/or on an as-needed basis.

A national cooperative contract has been awarded through OMNIA Partners to establish a contract for Janitorial Supplies and Equipment. In response to the solicitation posted by lead agency City of Tucson, Arizona, three (3) proposal responses were received and evaluated by a committee. Using the evaluation criteria that was established within the RFP, the committee elected to award to Network Services Company, with Imperial Dade/Nichols Paper & Supply Co., being the local representative of the Omnia Partners contract with Network Distribution.

Imperial Dade/Nichols Paper & Supply Co., Rochester Hills, MI 48309 has previously provided janitorial products to the City and performed satisfactory.
