SUBJECT: Support and Software Maintenance for HPE Storage Products

REQUEST:

City Council is requested to authorize a purchase order in the amount of \$75,000.00 for the City's HPE (Hewlett Packard Enterprise) server and storage system support and software maintenance contract for a two-year period to IT Solutions Group, Novi, Michigan.

REASON FOR PURCHASE:

The City posted an Invitation to Bid for the renewal of the City's HPE server and storage support and software maintenance contract utilizing the MITN system. Only one (1) bid response was received. Receiving one bid response was not totally unexpected, based on HP's vendor distribution model in which once a vendor is associated with your account they are provided first rights to the most competitive pricing and other vendor's will not bid when they verify this through their pricing request with HP. In order to ensure the City was being fair and competitive, we determined that it was in the best interest of the City to post the bid publicly and open it for competition. Unfortunately, only the one (1) bid was received as anticipated. The City has utilized IT Solutions Group in the past, and have been very satisfied with the service and support they have provided and recommend award of the HPE server and storage system support and software maintenance contract to them as the lowest, responsive, responsible bidder.

The MIS Department operates and maintains an HPE server and storage system for the City. Our support and software maintenance contract is up for renewal. This two year contract provides us with the updates and upgrades that are necessary to keep our infrastructure current and protected, as well as providing technical support for the hardware to the MIS Department.
