SUBJECT: Design-Build Innovation Hills Restroom Project

REQUEST:

City Council is requested to authorize a contract/blanket purchase order for the design-build of the Innovation Hills Restroom Project to Mando Construction, Mount Clemens, Michigan in the not-to-exceed project budget amount of \$1,009,444.00 and further authorizes the Mayor to execute an agreement on behalf of the City.

REASON FOR PURCHASE:

The City's purchasing division issued Request for Proposals for the design-build of the Innovation Hills Restroom Project utilizing the MITN system with four (4) proposal responses received. As part of the request, the City sought proposals for both a prefabricated and on-site build restroom building. Three (3) of the proposers submitted proposals for both types of structures, and one (1) proposer submitted for a prefabricated building only. In review of pricing and proposed buildings, the City deemed it to be in their best interest based on costs and other factors to pursue an on-site build for the restroom building.

A committee consisting of staff from Parks, Facilities, and DPS/Engineering evaluated the proposal responses received and subsequently shortlisted to three (3) firms and requested interviews. The interviews focused on questions relating to the proposed design-build team project approach (design process), familiarity with the project, experience with buildings similar to the one the city is requesting, construction method and materials, project management, maintenance and longevity, risk management, and post-construction support. Based on the proposals and interviews, the committee unanimously is recommending award of this contract to Mando Construction as the overall best value to the City based on their previous experience, demonstrated knowledge and well-thought-out plan and approach to the construction of the building demonstrated during their interview, proposed design-build team, and the ability to work with the City's to meet project timelines.

The City determined that a design-build approach would be best for this project in order to expedite the build process, along with the ability to have better worksite and design development coordination with the planned sewer main on the south side of Hamlin that is proposed for upcoming construction and will be presented to City Council at a later date (estimated early summer).

With all these factors considered, the City is recommending award to Mando Construction to complete the design-build for the Innovation Hills Restroom, which will include the lead in order to connect to the future construction of the sanitary sewer that will be presented to City Council in the near future.

This restroom will be open year-round to support winter operations and customer ice-skating and trail walking in the winter. The building also has two small bays for storage and a small staff break room.
