

**COST PARTICIPATION AGREEMENT**

**ADDITIONAL CONSTRUCTION**

Great Lakes Water Authority Improvements (Phase I)

Avon Road

East of Dequindre to 23 Mile Road (including Dequindre at 23 Mile Road intersection)

City of Rochester Hills

This Agreement, made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2023, by and between the Board of County Road Commissioners of the County of Oakland, Michigan, hereinafter referred to as the BOARD, and the City of Rochester Hills, hereinafter referred to as ROCHESTER HILLS, provides as follows:

WHEREAS, the BOARD and ROCHESTER HILLS have programmed the Great Lakes Water Authority improvements on Avon Road, as described in Exhibit "A", attached hereto, and made a part hereof, which improvements involve roads under the jurisdiction of the BOARD and within ROCHESTER HILLS, which improvements are hereinafter referred to as the PROJECT; and

WHEREAS, the estimated total cost of the PROJECT is \$395,000; and

WHEREAS, the BOARD and ROCHESTER HILLS have reached a mutual understanding regarding the cost of the PROJECT and wish to commit that understanding to writing in this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants set forth herein and in conformity with applicable law, it is hereby agreed between ROCHESTER HILLS and the BOARD that:

1. ROCHESTER HILLS approves of the PROJECT, declares its public necessity, and authorizes the BOARD to perform or cause to be performed, and complete the PROJECT along with all administration in reference thereto.

2. The PROJECT shall include construction engineering and total payments to the contractor. Any costs incurred by the BOARD prior to this agreement date shall be allowable.
3. ROCHESTER HILLS shall fund 100% of the PROJECT cost, estimated in the amount of \$395,000. Any PROJECT costs above the \$395,000 will be funded 100% by ROCHESTER HILLS.
4. Upon execution of this agreement, the BOARD shall submit an invoice to ROCHESTER HILLS in the amount of \$395,000 (being 100% of ROCHESTER HILLS' contribution).
5. Upon receipt of said invoice(s), ROCHESTER HILLS shall pay to the BOARD the full amount thereof, within thirty (30) days of such receipt.
