**NOTICE OF OPEN HOUSE AND PUBLIC HEARING
PROPOSED WINKLER MILL POND HISTORIC DISTRICT BOUNDARY CHANGES
HISTORIC DISTRICTS STUDY COMMITTEE**

NOTICE IS HEREBY GIVEN THAT THE CITY OF ROCHESTER HILLS HISTORIC DISTRICTS STUDY COMMITTEE will conduct a Public Hearing in accordance with Public Act 267 of the Public Acts of 1976 as amended and the Rochester Hills Historical Preservation Ordinance Section 118-126 through 118-134 to consider an ordinance which if approved, would revise the boundaries of the Winkler Mill Pond Historic District by removing the nineteen (19) properties noted below.

The Public Hearing will be held at the Rochester Hills Historic Districts Study Committee meeting on **Tuesday, October 12, 2023**, commencing at **5:30 PM**, at the Rochester Hills Municipal Offices, 1000 Rochester Hills Drive, Rochester Hills, Michigan 48309.

Prior to the Public Hearing, an Informational Open House will be held on **Thursday, September 14, 2023 from 5:30 p.m. to 6:30 p.m.** to provide the public the opportunity to discuss the proposed changes with the City staff and have any questions answered. The Open House will be held in the 2nd floor lobby of City Hall located at 1000 Rochester Hills Drive, Rochester Hills, Michigan 48309.

The following properties are proposed to be removed from the Winkler Mill Pond historic district (note that Winkler Mill Pond and any structures at the shoreline of the Pond that are associated with the parcels identified below are proposed to remain in the district. Therefore, any work or structures in, on top of, or adjacent to Winkler Mill Pond will still require review by the Historic Districts Commission):
