SUBJECT: Tree Maintenance Services Renewal

REOUEST:

City Council is requested to authorize a blanket purchase order/contract to CHOP, Grand Rapids, Michigan for tree maintenance services in the amount not-to-exceed \$218,470.00 through October 31, 2025.

REASON FOR PURCHASE:

In 2021 a Request of Proposals was issued on the MITN system and the initial award for tree maintenance was approved by City Council on November 15, 2021 for a three- year term to expire on October 31, 2024. The services include the removal of trees, tree pruning, storm damage response, and related arboricultural services in and along the public street right-of-ways and other public properties of the City on an as-needed basis.

The solicitation called for a three-year contract with two (2) one-year options to renew. Natural Resources has requested to exercise the first option year. The vendor has agreed to hold pricing and terms. The City has been satisfied with the services CHOP has provided over the past several years and requests approval to renew their contract for an additional one-year term.
