We at Niagara Murano (NM) would like to thank you for the opportunity to offer our services for the proposed City Hall Chiller Replacement Project located at 1000 Rochester Hills Drive in Rochester Hills, Michigan. This request for services corresponds to our recent meeting, conversations and emails discussing the need to design and install new Chillers for the City Hall Building. The Niagara Murano team have reviewed the site on May 16, and feel comfortable moving forward with the project.

#### PROJECT UNDERSTANDING

The City Hall CHILLER Replacement Project will replace the existing chillers with two (2) new chillers. The existing chiller has been breaking down often and creating difficulties finding and replacing broken components. By adding two (2) new reliable Chillers, City Hall will be able to function properly and maintain proper temperatures during peaks seasonal loads.

We have reviewed the general requirements of the repair project and will provide the following technical effort as follows:

#### **PART 1**: Prepare Documents:

- 1. Prepare Drawings and Specifications.
- 2. Prepare Electrical and Structural Drawings.
- 3. Provide Bidding & Award Services.
- 4. Provide Construction Administrative Services.
- 5. Provide Close-Out documents and As-Built documents.

**Note:** Site, Civil and Landscape work not included in scope of work.

- 2. Discuss key functional requirements, activities. design concepts/ alternates.
- 3. Prepare Electrical Drawings.
- 4. Provide Bidding & Award Services.
- 5. Provide Construction Administrative Services.
- 6. Provide Close-Out documents and As-Built Documents.
