SUBJECT: Cost Participation Agreement for Additional Construction on Avon/Dequindre 23 Mile Road

City File No. E17-018 Capital Improvement Plan Project MR-13C

REQUEST:

It is requested that City Council authorize the approval of the Cost Participation Agreement between the City of Rochester Hills and the Board of Road Commissioners for Oakland County (BOARD) for the Great Lakes Water Authority (GLWA) Avon/Dequindre/23 Mile Road project. The estimated total City cost associated with the additional construction items per the agreement is \$395,000.00.

REASON FOR PURCHASE:

The BOARD and City of Rochester Hills have collectively worked together on advancing this project and in doing so, the City requested that the BOARD include additional construction items with an estimated cost of \$395,000.00. The additional work is summarized in the attached cost participation agreement and includes landscaping amenities for the inner circle of the proposed roundabout, retaining wall construction, a midblock High-Intensity Activated Crosswalk (HAWK) signal crossing at the existing Yates Cider Mill Avon Road crosswalk, and a contribution of construction engineering expense to cover construction engineering work performed by the Road Commission for Oakland County field staff.

The GLWA has retained a Construction Manager at Risk (CMAR), Kiewit, to construct the water main and roadway improvements for the project. Kiewit has obtained bid pricing for the construction items included in the cost participation agreement.

BUDGET:

Funding for the project was included and carried over from the FY 2022 Adopted Budget.
