## Notice of City Council Public Hearing Draft Updated Wetland Inventory Map

Rochester Hills Residents,

Notice is hereby given that the City of Rochester Hills City Council will conduct a public hearing, pursuant to the Wetland and Watercourse Protection Ordinance, Article IV, Chapter 126, of the Code of Ordinances of the City of Rochester Hills, Oakland County, Michigan. This correspondence shall serve as notice that the draft of the City's updated wetland inventory map is available for public inspection prior to its finalization. The wetland inventory map and corresponding Wetland and Watercourse Protection Ordinance was originally adopted in 2002.

The draft updated wetland inventory map can be found on the City's website at the following location: <http://rochesterhills.org/wetlandinventorymap>. The map can also be viewed at City Hall at the Planning and Economic Development Department (2<sup>nd</sup> Floor).

As an owner of record on the City's tax roll you are receiving this correspondence because your property may include designated wetlands which may be regulated by Article IV, Chapter 126, of the Code of Ordinances of the City of Rochester Hills. Please note that the draft updated wetland inventory map does not create any legally enforceable presumptions regarding whether property is or is not included on the inventory map or is or is not in fact a wetland and that the draft updated wetland inventory map may not necessarily include all of the wetlands within the city that may be subject to this article.

The public hearing will be held at the Rochester Hills City Council meeting on **Monday, March 18, 2024**, starting at **7:00 PM**, at Rochester Hills City Hall, 1000 Rochester Hills Drive, Rochester Hills, MI 48309. The proposed wetland map and associated information can be viewed on the City's website through the 2024 Natural Features Inventory Draft Update Map on the Planning & Economic Development webpage.
