OFFICE OF THE CITY CLERK NOTICE OF PUBLIC MEETING REQUEST FOR SITE PLAN APPROVAL AND TREE REMOVAL PERMIT

TO ROCHESTER HILLS RESIDENTS:

NOTICE IS HEREBY GIVEN THAT THE ROCHESTER HILLS CITY COUNCIL, in accordance with the Open Meetings Act, Act 267 of the Public Acts of 1976 as amended and the consent judgment covering this property, will conduct a Public Meeting, pursuant to the Tree Conservation Ordinance, Chapter 126, Article III, of the Code of Ordinances of the City of Rochester Hills, Oakland County, Michigan. This notice shall serve as a minimum of seven days' notice to all adjacent property owners regarding the request for a Tree Removal Permit as described below. The applicant is also requesting Site Plan approval.

REQUEST: Tree Removal Permit Approval (File PTP2024-0003). Per Section 126-326 Permit Required, a request to remove five (5) regulated trees with five (5) replacement trees required. The applicant is proposing to provide five (5) replacement trees onsite.

REQUEST: Site Plan Approval (File PSP2023-0007). Per Section 138-2.200 Site Plan Review, a request for site plan approval for the project to construct four new buildings: an athletic facility, a light industrial building, a drive-through facility, and a retail building.

LOCATION: Vacant located west of Marketplace Dr. and north of S.

Adams Rd., zoned HB Highway Business and the property is also under a consent judgment, Parcel No. 15-30-301-043.
