SUBJECT: Drexelgate Road Diet and Pathway Project - Construction Engineering Services (CE)

City File Number E22-003; Capital Improvement Project Numbers MR-61 and PW-11

REQUEST:

City Council is requested to authorize a contract/blanket purchase order for construction engineering (CE) services for the Drexelgate Road Diet and Pathway Construction Project to Hubbell, Roth & Clark, Inc. (HRC), Bloomfield Hills, Michigan in a not-to-exceed amount of \$230,791.00.

REASON FOR PURCHASE:

The Michigan Department of Transportation (MDOT) recently received bids for the Drexelgate Road Diet and Pathway Construction project. Based on the 2023 department workload, the Department of Public Services has determined an engineering consultant is needed to provide the construction engineering services.

Staff recommends Hubbell, Roth & Clark, Inc. to perform the construction engineering services to the City. The attached proposal describes the scope of services and corresponding expense to complete the work.
