## COUNCIL AND YOUTH COMMITTEE REPORTS

### Rochester Hills Government Youth Council (RHGYC):

**President Deel** introduced RHGYC Representative Shreya Pillai.

**Ms. Pillai** shared that she is a senior at Rochester High School and this is her fourth year serving on the RHGYC. She stated that on December 4, 2022, the RHGYC volunteered at the Rochester Area Hometown Christmas Parade by directing people to the warming stations. She added immediately after the Parade, the RHGYC met at Meijer on Rochester Road to shop for the family that they adopted through the New Day Foundation Adopt a Family Project. She shared that they were able to get the family items from both their needs' and wants' lists and they will be wrapping the gifts at their next meeting. She added that the RHGYC Christmas Party will take place on December 14, 2022.

**Ms. Mungoli** shared that the Rochester Area Hometown Christmas Parade was an exceptional event. She recognized the City Staff that helped keep the Parade safe. She displayed photos from the Parade and thanked everyone that attended as well as assisted with the event.

**Chris McLeod**, Planning Manager, and **Mike Viazanko**, Building/Ordinance/Facilities Director, were present.

**Mr. McLeod** shared that there are a series of technical Ordinance amendments proposed by the City Attorney and City staff. He noted that there were a number of things that needed clarification or tweaking to ensure that the Ordinance is up-to-date. He added that recent court cases had prompted amendments to the City's off-premise sign regulations. He stated that this is the First of two

readings for the amendments to this Ordinance.

**President Deel** thanked Mr. McLeod and Mr. Viazanko for bringing the Ordinance amendments before Council.

**Mr. Blair** thanked Mr. McLeod and stated that he is thrilled to see regulations on the brightness of illuminated signs, he questioned exactly how bright illuminated signs are allowed to be, according to the Ordinance language.

**Mr. McLeod** responded that generally 0.1 foot candles is equivalent to moonlight. He added that if there is an issue that a sign might be too bright, it probably is not in compliance with the Ordinance.

**President Deel** explained that illumination can be measured with specific devices to ensure the sign is in compliance.

**Ms. Mungoli** stated that the Ordinance does not clarify the regulations for political signs. She questioned whether there are restrictions for political signs. She stated that the maximum allowance for all temporary signs originally, had been ten square feet and now it is two at six square feet. She questioned the modifications that had impacted the maximum square footage.

**Mr. Christ** explained that the Ordinance modification in regard to off-premise signs is content neutral and would be a prohibition in regard to off-premise locations.

**Ms. Welch** responded that the City does have an Ordinance in regard to political signs; however, it is not presented tonight because there are no modifications. She added that during a political season, the Ordinance states the maximum allowance is 60 square feet or ten signs.

**Ms. Mungoli** pointed out that the square footage chart in the Ordinance has reduced the signage square foot allowance. She questioned the reason for the reduction and noted that the chart states a reduction of half the previous allowed signage size.

**Ms. Welch** replied that the maximum area of individual signs had not changed, it has always been six square feet; however, instead of having ten square feet of signage on a yard, the Ordinance now allows two six square foot signs. She added that the total signage amount has increased. She stated that there was a typo in the Ordinance and that will be corrected, the chart should not state a reduction of half the size allowance.

**President Deel** requested that the First Reading Resolution be amended to include the changes in Non-Residential Uses in all districts under Wall Signs from one sign to two signs and Non-Residential Uses and Residential Districts Freestanding chart, change all marked one sign to two signs.

**A motion was made by Blair, seconded by Hetrick, that this matter be Accepted for First Reading by Amended Resolution; indicating that non-residential uses in all districts under Sec. 134-6 Wall Signs, would be two signs and under Section 134-9 Temporary Signs, non-residential uses in residential districts freestanding signs would be modified from one sign to two signs. The motion carried by the following vote:**

**Chris McLeod**, Planning Manager and **Shepard Spencer**, Applicant, were present.

**Mr. McLeod** shared that request is for an approval of a Conditional Use to allow the sale and consumption of alcoholic beverages at Little Tree Sushi Bar located at the former Outback Steakhouse at 1890 South Rochester Road. He added there are no potential concerns with noise at this particular location and stated that the Applicant is relocating his current restaurant from Royal Oak to Rochester Hills. He noted that Mr. Spencer would be transferring his existing liquor license to this site; he is not requesting a quota liquor license. He shared that Little Tree Sushi Bar has been in operation for 27 years and offers dine-in Japanese, Sushi, Thai and Filipino Cuisine. He stated that the Planning Commission held a Public Hearing on November 15, 2022 and unanimously recommended approval of the Conditional Use request.

**Mr. Spencer** stated that this is his fifth restaurant and he is looking forward to

*operating his business in Rochester Hills.*

**Ms. Mungiola** welcomed Mr. Spencer to Rochester Hills and asked when the Grand Opening will take place.

**Mr. Spencer** replied the Grand Opening is pending upon approvals. He added that he is hopeful to be open by February 2023.

**Vice President Bowyer** thanked Mr. Spencer for choosing to open his business in Rochester Hills.

**Mr. Hetrick** stated that it is clear that Mr. Spencer loves what he does and he welcomed him to Rochester Hills.

## LEGISLATIVE & ADMINISTRATIVE COMMENTS

**President Deel** shared that the Christmas Parade was magnificent and it was nice to see the annual tradition return back to the City.

**Mr. Hetrick** shared that he attended an event for Cass Community Social Services and added that this was the sixteenth year in a row that both he and his wife have attended this event in support of Cass Community Social Services. He added that the Christmas Parade was great and was an outstanding way to interact with the Community during the Holiday season.

**Mayor Barnett** provided the following City updates:

- The Christmas Parade was awesome and a great time was had by all. He displayed photos from the Parade.
- A terrible situation happened to a couple in the Community; they were found perished in their home due to a faulty carbon monoxide detector. He stated the City wants to help keep everyone safe and encouraged residents to contact the Fire Department at 248-841-2705 for a free carbon monoxide detector that can also be installed for free.
- The Avon and 23 Mile Road project, near Yates Cider Mill, Phase II started today. He noted that Avon Road will be closed for some time while construction continues.
- Right Down the Street podcast's newest edition features the Barnett siblings.
- The Community celebrates the holidays in a variety of ways such as Meadowbrook Hall's Light Show, Meadowbrook Theater's Christmas Carol, Light the Village at the Village of Rochester Hills and the Downtown Rochester Lights. He stated that all the events are great opportunities to celebrate the holiday season in the Community. He noted that at the Light the Village event, during the fireworks celebration, a couple got engaged.

- The City has one of the largest Albanian populations in the United States and the City hosted a ceremony in honor of Flag Day at City Hall on November 28.
- The City participates in '30 Days of Giving' every November and December. He stated that each Department coordinates a way to give back to people in the Community. He noted that some departments collect food for local pantries, bake cookies for the Older Persons' Commission (OPC) and put up holiday decorations at Leader Dogs for the Blind.
- Innovation Hills was decorated for the holidays with lights and a Christmas tree. He thanked the Parks Team for bringing holiday cheer to Innovation Hills.

**Bill Fritz**, Public Services Director, stated that the Michigan Department of Environmental Great Lakes and Energy (EGLE) is the Storm Water Management Regulatory Agency in Michigan. He added that the Municipal Separate Storm Sewer System (MS4) Program is part of EGLE and the Program's goal is to reduce the discharge of pollutants into the surface water of the State. He stated that Rochester Hills Storm Water Criteria is part of the Rochester Hills Engineering Design Standards that were adopted in 2019. He added that the City's MS4 Permit is renewed with EGLE every five years and the City had recently submitted the application for renewal; however, EGLE has changed its requirements. He noted that EGLE reviewed the City's application and informed the City that some standards did not meet their new criteria; therefore, the request is to modify the City's Engineering Standards to be in compliance according to State law.

He explained that there are three components to the Storm Water Management:



- On-Site Detention that creates a certain volume to store storm water.
- Channel Protection that protects downstream bodies of water from eroding by detaining rainfall.
- Water Quality Treatment that detains the first flush (oils, solids, grit) on-site that get washed into the system.

He added that currently the Channel Protection component of the City's standards based on one-year/24-hour storm is 1.87 inches of rainfall and EGLE is requiring a two-year/24-hour storm at 2.39 inches of rainfall. He stated that the Water Quality Treatment is currently set at 0.5-inch of rainfall and EGLE is requiring 1-inch of rainfall.

**President Deel** thanked Mr. Fritz and reiterated that the changes to the City's Engineering Standards are to bring the City in compliance with the current State standards as promulgated by EGLE.
