SUBJECT: Grant Administration and Oversight Assistance for EGLE Restoration and Remediation Grant

REQUEST:

City Council is requested to authorize a contract/blanket purchase order for grant administration and oversight assistance services related to the EGLE Restoration and Remediation Grant the City was awarded on September 29, 2023 to ASTI Environmental, Brighton, Michigan in the amount not-to-exceed \$1,900,000.00 through September 30, 2028 and further authorizes the Mayor to execute an agreement on behalf of the City.

City Council is requested to waive Section 2-273(b) the 3-year requirement for long term contracts, under Section 2-281, which allows City Council the authority to waive any regulation or procedure pertaining to purchasing, deeming it to be in the best interest of the City to allow a 5-year contract.

Tom Wackerman from ASTI will be present at the meeting to give an update on the work the City has done on this grant to date.

REASON FOR PURCHASE:

ASTI Environmental is the City's Environmental and Wetland Consulting Firm and was selected and awarded a contract through an RFP process. The City is recommending ASTI Environmental be retained to provide grant administration, oversight, and other services as needed to administer the EGLE Restoration and Remediation Grant received by the City is September. ASTI Environmental is qualified to assist the City with this project and it is the City's recommendation to retain their services for this project, based on their experience, qualifications of staff, and project approach.
