We are very excited to have the Walton Oaks project coming before the Rochester Hills Planning Commission for final site plan approval on April 2. The support of Sara Roediger's team has been tremendous and we're pleased that our development partner, Three Oaks Communities (TOC), has now met all of the City's requirements to proceed with land development.

I am also pleased to report that TOC closed on two loans totaling \$2 million from the Oakland County Housing Trust Fund on Friday, March 15. The Walton Oaks project will receive \$500,000 to support land acquisition and development.
