

TEMPORARY EASEMENT

The purpose of this Temporary Easement is to grant to the City the right to move workers, equipment, and materials on, over, and through the Property and ~~to store~~ ~~equipment, material, and~~ excavated matter on the Property. This Temporary Easement includes, but is not limited to, the consent of the Grantor(s) to the removal of any trees, shrubs, and/or vegetation, to grading, to the temporary occupancy of the Property by public utilities, and to other matters which, in the sole discretion of the City, may be necessary in connection with the Project. Grantor(s) waive(s) further notice of such actions.

The permission stated in this Temporary Easement shall begin on the date the Project begins and shall expire at the completion of the Project. The work described above shall be constructed and/or restored in a workmanlike manner and in accordance with applicable state and county standards. Upon completion of the work described above, the City and its agents shall have no further or ongoing responsibilities in relation to the work described.
