

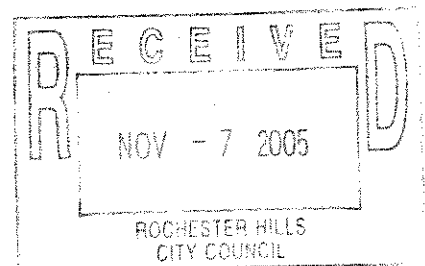
I am not affiliated with any committee or conservation organization beyond my Homeowner's Association. I would be an independent voice.


