REOUEST:

That the Rochester Hills City Council approves the Highway Easement from Rayconnect, Inc. for the Austin Avenue Extension and authorizes payment to the land owner in the amount of \$7,321.95.

REASON FOR PURCHASE:

On August 4, 2008, City Council approved a contract between the City of Rochester Hills and Hubbell, Roth & Clark, Inc. (HRC) to acquire ROW for the Austin Avenue Extension Project. A workable plan has surfaced due to recent negotiations between the City and a proposed business named Rayconnect, Inc. The City has moved forward with the project and is working to assist Rayconnect, Inc. in their desire to open their new facility by May 2009.

HRC has been in the process of acquiring the ROW and must meet a deadline in order to have Rayconnect, Inc. open by May 2009. This is the last Highway Easement necessary before construction can commence.
