CALL TO ORDER

President Rosen called the Regular Rochester Hills City Council Meeting to order at 7:33 p.m. Michigan Time.

PLEDGE OF ALLEGIANCE

APPROVAL OF AGENDA

PUBLIC COMMENT

Ms. Sue Ann Douglas, 1200 N. Telegraph Road, Oakland County Commissioner for District 12, stated the County Board packets are now on the Internet. She advised there were three new House Bills that affect Solid Waste Planning. She provided written information on each of the new House Bills. She asked Council to read each one and send her any concerns they may have with them, and she would in turn take their comments to Lansing.

Mr. Jay Fedewa, 2172 Warrington, Executive Director of the Family Rights Coalition, reported this group was successful in stopping the vaccination of sixth graders for the Human Papiloma Virus. He informed Council they are an advocate for equal parental responsibility in the case of divorce or unmarried situations. He stated the Family Rights

Coalition advocates for both men and women. He encouraged Council and the public to go to their website which is www.frcmi.org or, you can email them at info@frcmi.org.

Mr. Lee Zendel, 1575 Dutton, explained the Council Member Pension Plan for the City of Rochester Hills consists of an amount equal to 12% of their pay set aside in a 401A Account. He stated of the \$49 million the City receives, the \$1100.00 the Council members earn for their Pension, equates to about 22 thousandths of one percent. He commented there were other important items the Council should be addressing. He stated regarding the issue of turning the City's dispatch over to the Oakland County Sheriff's Department, that Oakland County may not be the lowest bid. He noted that a more important problem in the City is the need for road reconstruction and repair, which could cost in excess of \$55 million and could reach \$100 million.

Ms. Deanna Hilbert, 3234 Quail Ridge, reiterated her question regarding Grand Sakwa and the \$2.5 million that she understood would come from credits applied to the construction of the ring road as well as waivers of fees, etc.

President Rosen advised Ms. Hilbert that he would get her the information that she was requesting.

LEGISLATIVE & ADMINISTRATIVE COMMENTS

Ms. Raschke discussed an article from the Oakland Press regarding the Michigan State Police conducting speed studies on gravel roads once the roads are dry. She stated there are 770 miles of gravel roads in Oakland County and she was pleased to see the speed studies taking place.

Mr. Ambrozaitis responded to Mr. Zendel's comments regarding the Council Pension Plan. He stated he would never accept the Pension from the City of Rochester Hills and he would like the other Council members to follow his example. He noted the City needs to have the dispatch issue addressed as the money for the study has already been budgeted.

Mr. Duistermars stated he was not in favor of changing the City's current dispatch service, as he is more concerned with the level of service the residents of Rochester Hills receive than monetary savings. He commented the salary he receives is donated to a charity and if he accepts the City Pension, that would be donated to a charity as well.

Mr. Hooper clarified there is a total of \$25,000.00 for an RFP for a dispatch study. He stated the City staff would be responsible for soliciting proposals. He commented he donated his salary to charity and would consider donating any Pension to charity that he would receive.

Mr. Yalamanchi stated he is a participant in the Michigan Municipal League Technology and Rights of Life Committee. He advised this group is handling the new Cable Franchise Legislation. He informed Council that the timeframe for the review and approval of the legislation is very short. He requested Mr. Staran to share with the Council his information on the progression of the legislation.

Mr. Staran, City Attorney, stated the City just received the Proposed Video Local Service Franchise Agreement from AT & T. He agreed with Mr. Yalamanchi as to the quick turnaround time required for these documents. He stated the City has 15 (fifteen) days to analyze the document for completeness, and then 30 (thirty) days after that to decide whether to approve it or not.

Sarah Bachleda, Rochester Hills Youth Council Representative, stated the Youth Council is collecting school supplies for a school in Pontiac that is in need of crayons, markers, backpacks, etc. She advised that the Youth Council has placed a bin in the

lobby of City Hall for anyone wishing to donate school supplies. She commented the bin would be available for donations throughout the month of April. She stated the Youth Council would be registering students who are 18 (eighteen) years of age to vote in the local high schools.

Mayor Barnett advised the mock Council the City's Youth portrayed at the MML Conference consisted of 150 participants. He acknowledged the Rochester Competitive Cheer Team for winning the State Championship for the 11th time in 14 (fourteen) years. He also acknowledged the Rochester College Men's Soccer Team, for being the UCA and National Invitation Tournament Champions. He commented on the large turnout at Community Central Bank for the unveiling of a new mural of the City of Rochester Hills at the turn of the century. He noted it was a wonderful piece of art and he encouraged everyone to take a look at it as a tribute to our community.

Ms. Raschke stated she had been contacted by numerous citizens regarding the issue of recreational vehicles on personal property and the legality of it. She stated it was legal to have the recreational vehicles on personal property if they are parked behind the house line.
