**SUBJECT:** Extrication Equipment

## **REQUEST:**

City Council is requested to authorize the purchase of new extrication equipment consisting of two (2) cutters, two (2) spreaders, four (4) combination tools, six (6) gas powered power units, two (2) rams, hoses and installation. The equipment will be purchased through Apollo Fire Equipment Company, Romeo, Michigan, in the amount of \$84,400.00.

## **REASON FOR PURCHASE:**

## Purchasing:

The City solicited a request for information for extrication equipment in May of 2005. Each responding vendor was asked to provide demonstrations of their equipment to Fire personnel in June. Based on the demonstrations a request for proposal was drafted and solicited using the MITN website. The proposal called for the trade in of the City's existing extrication tools that are approximately twenty years old. To be traded in are three (3) Omni II Combination tools, five (5) power units, one (1) spreader and two (2) cutters. All equipment is fully depreciated and in need of replacement.

After review of the proposals it was determined that purchasing the Hurst product line from Apollo Fire was in the best interest of the City. The two lowest vendors did not meet all specifications and the lowest proposed vendor's products could not be used with the City's current equipment. Since the City is not trading in all extrication equipment (rams and combo units) it was determined that remaining with the Hurst product line was in the best interest of the City.

### Department:

The Fire Department has used Hurst for 20+ years and have found them to be very dependable. The company has agreements with the automakers which allow Fire Department Employees to receive the latest training on new vehicles in respect to stronger steel being used and the new hybrid vehicles.

## **BUDGET:**

Funds for the purchase of extrication equipment are provided for in the 2005 Fire Apparatus Fund. Cost of the new equipment includes a trade in value of the City's current extrication equipment including three (3) Omni II Combination tools (\$1,200.00), five (5) power units (\$1,000.00), one (1) spreader (\$200.00) and two (2) cutters (\$400.00).
