PUBLIC COMMENT

Ms. Nancy Raffler, 713 West Auburn, explained that during the previous evening's Planning Commission meeting, Council Member Hill mentioned that Ms. Raffler's property had been discussed in a City Council Closed Session meeting. She questioned the legality of this and asked what specifically had been discussed.

President Dalton explained that City Attorney John Staran was not present and Mr. Ternan was unable to answer her questions. He assured Ms. Raffler that he would have Mr. Staran prepare a response for her immediately.

Mr. Lee Zendel, 1575 Dutton Road, described an editorial in the Oakland Press that stated that the proposed road millage rate "overstates the need." Mr. Zendel expressed his disagreement with this opinion and noted that the requested millage rate was likely too low when considering the current cost of crude oil, as well as other road improvement materials.

LEGISLATIVE & ADMINISTRATIVE COMMENTS

Mayor Somerville read a letter the City received from the Charter Township of Shelby expressing the "thanks of a grateful community" and praising the Rochester Hills Fire Department for assisting with a recent structure fire.

Ms. Raschke expressed her disappointment that Governor Granholm had vetoed a bill that would have removed the barricade on Tienken Road between Rochester Hills and Auburn Hills. She encouraged residents to express their disappointment as well by faxing letters to the Governor at 517-335-6863.

Mr. Barnett stated that he had attended the Grand Opening of the new County Courthouse on Barclay Circle and encouraged residents to visit the new building as well.

PUBLIC COMMENT:

Mr. Lee Zendel, 1575 Dutton Road, praised the work and effort that went into this budget, noting that Council "has gone through the budget line by line." He expressed his disappointment with the level of spending on public safety, but noted that "for the most part, the Administration and City Council have produced an excellent budget."

COUNCIL COMMENTS:

Ms. Holder stated that, because she has "major concerns" with the management of the City's fire services, she could not support the portions of the budget that included the dedicated Fire Millage.

Ms. Raschke agreed with Ms. Holder, stating she was "uncomfortable with the public safety in our community." She also expressed her belief that future budget Work Sessions should be telecast so residents can "see what we go through in these budget processes."

Ms. Hill expressed an opposing view with regards to the Fire Department, noting that she felt the Fire Millage could have been reduced slightly. Ms. Hill then expressed her strong belief that the City needs a City Administrator, noting that the position exists in the Mayor's Department Budget but is unfunded for this year.

Mr. Barnett indicated that the City's Fire Department is currently meeting their benchmark requirements of service under the existing budget. He stated that the City Council and City Administration "did a good job of putting together a fiscally responsible budget."

COUNCIL COMMITTEE REPORTS

Mr. Duistermars indicated that the upcoming Public Safety Committee meeting scheduled for November 1st will likely be rescheduled to November 8th, due to the General Election on November 2nd. He stated that he would like to arrange through the Clerk's Department a "town hall"-type format for the November 8th meeting and invite all of the full-time firefighters and paid-on-call firefighters to discuss various issues concerning the City's Fire Department.

Ms. Hill requested that the Community Development & Viability (CDV) Committee bring forward information from their meeting regarding the roadside stands and Christmas tree lots ordinance. She stressed that she did not want the Committee to make any decisions regarding the ordinance prior to receiving City Council's "feedback" on the issue.

Mr. Barnett, noting that the author of the letter Council received asking that the roadside stand issue be examined would be invited to attend the next CDV meeting, assured Council that this meeting would be for "information gathering" purposes only and that he has no intention of it "being an ordinance change."

Mr. Barnett further noted that the City's continued participation in the NO-HAZ program would be examined at the next CDV meeting as well.

ANY OTHER BUSINESS

Ms. Hill, noting that the budget process is "more or less completed for the year," reiterated her belief that Rochester Hills needs a City Administrator. She suggested that this could be corrected via a budget amendment.

Mr. Barnett encouraged residents to "tune in to Channel 55" for informational programs regarding the City's ballot proposals for the General Election.

Ms. Hill announced that there would be a final Town Hall meeting regarding the City's ballot proposals on Thursday, October 28th at 7:00 p.m. in the City Hall Auditorium.

President Dalton announced that City Council had received an invitation to participate in the Chamber of Commerce Leadership Day Event to be held the following day at City Hall and Rochester College. He expressed his disappointment that they had not been informed of the invitation until that day, noting he would be unable to attend the event on such short notice. However, he encouraged his fellow Council members to attend, stressing that "the more we can work with the surrounding communities, the better." He suggested that the City Clerk prepare a letter advising the Chamber that, had they received proper notice, the Council would have attended in greater numbers.

President Dalton announced that the City Council Youth Representatives intended to enter a float in the upcoming Christmas Parade. Noting that the City did not intend to build a float this year, President Dalton requested that the Mayor support the Youth Representatives' efforts by dedicating the City's float fund to the Youths. He explained that the students would design and build the float and only asked that City Council members walk with them during the parade.

Mayor Somerville agreed to allow the students to use the City's parade float budget.
