**Building Authority**

**To fill one (1) vacant term ending December 31, 2015**

Building Authority acquires and arranges for construction on property acquired by the City when bond sales are required.

---

**Canvassing Board**

**To fill two (2) vacant terms ending December 31, 2013**

**(One Republican Representative and One Democrat Representative)**

Established by State Election Law, the Canvassing Board certifies results following every City Primary and General election. The Board is comprised of two Republicans and two Democrats. One Republican position and One Democrat Representative position are up for appointment and will be filled.

**Historic Districts Commission**

**To fill three (3) vacant terms ending December 31, 2012**

Established by Chapter 118, Historic Preservation, of the Code of Ordinances of the City of Rochester Hills pursuant to State of Michigan Public Act 169 of 1970, the Historic Districts Commission (HDC) investigates requests for establishing or changing Historic Districts, approves or disapproves plans for work on resources within Historic Districts and maintains a list of potential districts.

**Historic Districts Study Committee**

**To fill four (4) vacant terms ending December 31, 2011**

Established by City Council pursuant to Chapter 118, Historic Preservation, of the Code of Ordinances of the City of Rochester Hills, Oakland County, Michigan. The Historic Districts Study Committee serves as a standing committee to conduct duties as prescribed in the Ordinance.

**Human Resources Technical Review Committee**

**To fill two (2) vacant terms ending December 31, 2010**

The Rochester Hills Human Resources Technical Review Committee was created on November 29, 2006 to attend to the requirements of City Council's Policy for Salaries of Department Directors and Mayor, and Per Diem Fees for City Boards and Commissions and City Council's Policy for Review of Performance Appraisals for City Council Appointed Department Directors.

**Rochester Avon Recreation Authority**

**To fill one (1) vacant term ending December 31, 2012**

The Mission of the Rochester-Avon Recreation Authority (RARA) is to provide an extensive and varied recreational program, enhancing personal enrichment, and providing for the community's leisure needs.
