**REQUEST:**

City Council authorization of a blanket purchase order to Consumers Energy, Lansing, Michigan in the amount not-to-exceed \$132,610.00 for the purchase of natural gas for various City owned buildings through December 31, 2015.

**REASON FOR PURCHASE:**

Through the State of Michigan's MiDeal Program, the City participates as a cooperative member in the purchase of natural gas, utilizing a State qualified and selected vendor, including consulting services and natural gas brokering. In June 2009, the City began using Constellation Energy as its source of the natural gas commodity through the MiDeal Program, with firm pricing for the commodity only. The gas customer charge and distribution charge from Consumers Energy continues and may fluctuate as specified by the natural gas utility and the Michigan Public Service Commission.

The City currently pays a fixed rate of \$4.50/MMBtu for its facilities. The MiDeal contract's fixed rate historically has remained less than the "utility's" rate.

The current reported Consumers Energy rate is in excess of \$5.00 (as provided to the City on 12/4/2014). Utilizing the Choice Program the City continues to save in its purchase of the natural gas commodity under the current rate structure and annual consumption.
