SUBJECT: Hamlin Road Irrigation System Between Crooks and Livernois

REOUEST:

The Department of Public Services requests that City Council award a contract for the Hamlin Boulevards Irrigation System to Michigan Automatic Sprinkler, Inc. of Commerce, Michigan in the amount of \$33,720.00 with a 10% contingency of \$3,372.00 for a total not-to-exceed amount of \$37,092.00, and authorizes the Mayor and Clerk to execute the contract on behalf of the City.

REASON FOR PURCHASE:

The City requested proposals for the design, furnishings and installation of an irrigation system for the Hamlin Road Boulevards between Crooks and Livernois. There were four (4) proposals submitted on September 26, 2013 in response to the Request for Proposals. City staff evaluated and scored the proposals and there was unanimous agreement that Michigan Automatic Sprinkler, Inc. be selected as the responsive and responsible contractor providing the best value and warranty. Michigan Automatic Sprinkler has previously installed the irrigation systems along the Livernois and Crooks Road Boulevard projects with a satisfactory result.

The City will be providing the water taps only, with the remainder of the work to be competed by the contractor.

The funding source for the boulevard irrigation system will come from the METRO ACT identified in State Public Act 48 of 2002. The Telecommunications Law created a uniform statewide fee schedule for telecommunication providers, which is paid to METRO. The act states that municipalities may use the funds received under the act solely for rights-of-way purposes.
