#### **PURPOSE:**

City Council is requested to consider approval of the issuance of a flood plain use permit to the Great Oaks Country Club for the proposed Sargent Creek Stream Restoration and Soil Erosion and Sedimentation Control.

#### **DISCUSSION:**

The Great Oaks Country Club proposes to conduct stream bank restoration and weir rehabilitation to improve conditions along the Sargent Creek, which runs through the Great Oaks Golf Course. These improvements will improve site erosion and flooding issues that the Golf Course has experienced.

The Michigan Department of Environmental Quality (MDEQ) flood plain use permit was issued October 21, 2004. A hydraulic model generated by the HEC-RAS computer program was prepared to evaluate impacts to the Sargeants Creek from the proposed restoration and weir rehabilitation. The calculated 100-year flood plain elevation resulting from the stream bank restoration and weir rehabilitation resulted in a reduction of approximately 0.4 feet.

### FISCAL INFORMATION:

This project will have no budget impacts and should require no additional staffing requirements.

### **RECOMMENDATION:**

The Department of Public Services recommends that City Council approve the Flood Plain Use Permit request by the Great Oaks Country Club.
