The filing deadline for all candidates is Tuesday, June 19, 2007 at 4:00 p.m. The withdrawal deadline is Friday, June 22, 2007 at 4:00 p.m. At that time, we will prepare the official list of candidates and addresses.

Filing Requirements (for all candidates) - set by the City Charter (Chapter IX) and are as follows:

- 1) Be a registered elector in the City of Rochester Hills.
- 2) Have residency of one (1) year prior to filing deadline.
- 3) District candidates must reside within the district.
- Candidates for City office must file nominating petitions containing not less than fifty (50) or more
 than seventy-five (75) signatures of registered electors of the city/district. Candidates for District City
 Council Member must obtain signatures from only those registered electors in their district.
- **Library Board candidates** must file nominating petitions containing not less than forty (40) or more than one hundred (100) signatures.

Each set of petitions for candidates includes:

- 1) 5 petition sheets. These will contain enough space for 75 signatures. The heading for petitions must be completed prior to circulation (Instructions to circulators on back of petition sheets. More petition sheets will be provided for Library Board candidates if requested.)
- 2) 1 Affidavit of Identity (3-part form). This must be completed, signed, and notarized. The Clerks Office can notarize the candidate's signature if the candidate delivers the petitions in person. A copy of the Affidavit of Identity serves as the candidate's receipt for Nominating Petitions.

A candidate who wishes to withdraw must submit their request in writing and must be received by the Clerk's Office no later that 4:00 p.m. on Friday, June 22, 2007. If there are "not more than twice the number of candidates for each office to be filled as there are persons to be elected, the Primary Election shall not be held" (per Charter).

All nominating petitions and affidavits are available at the Clerk's Office. Those interested in School Board petitions may obtain them at the Clerk's Office. There will be additional filing information for School Board candidates as soon as it's available from the County Clerk (School Board Candidates file petitions with County Elections Division). The City Clerk's Office is open Monday through Friday from 8:00 a.m. until 5:00 p.m., City of Rochester Hills Offices, 1000 Rochester Hills Drive, Rochester Hills, Michigan 48309, 248-656-4630.

The Election Commission will meet on Thursday, August 2, 2007 at 9:30 a.m. and Thursday, September 27 to appoint election workers for the city elections. The Canvassing Boards will meet to canvass the results of each election on Wednesday, September 12 at 4:30 p.m. and Wednesday, November 7 at 4:30 p.m.
