**SUBJECT:** Purchase Authorization for Rock Salt for the 2014/2015 Winter Season

### **REQUEST:**

City Council is requested to authorize a blanket purchase order to Detroit Salt Company LLC, Detroit, Michigan, for the purchase of rock salt in the amount not-to-exceed \$155,000.00 through June 30, 2015.

#### **REASON FOR PURCHASE:**

Sealed bids were solicited for sodium chloride (rock salt) by the City of Farmington Hills on behalf of the Michigan Intergovernmental Trade Network (MITN) in April, 2014. As a cooperative bid 78,850 tons of salt for 32 governmental entities, including the City of Rochester Hills, was bid. The lowest, responsive, responsible bidder was Detroit Salt Company LLC at a bid price of \$47.41 per ton.

Utilizing the new Salt Storage Facility, the Department of Public Services was able to purchase enough salt, at last years lower rate of \$39.82, to fill the storage facility (3,500 tons). The DPS was then able to reduce the estimated quantity to 2,500 tons based on current inventory and the efficient application of brine and other ice control products.

Under the terms of the contract each agency guarantees ordering a minimum of 70% of the award total, but is also allowed to order up to 130% of their estimated usage each year at the price bid. Quantities will be managed by the Department of Public Services to insure an adequate supply.
