Dear Mr. Elwert:

Hubbell, Roth & Clark, Inc. (HRC) is pleased to offer engineering services to the City of Rochester Hills for the subject project. We propose that all items of work be completed under the terms and conditions of our existing Agreement for Professional Engineering Services.

The proposed parking lot improvements, Pond Trail and Woodland Trail was bid under separate contract as part of the City of Rochester Hills 2018 Pathway Program. The project was awarded to Proline Asphalt. The City has requested HRC to provide construction administration and oversight for the portion of work located in Innovation Hills. A breakdown of our proposed services and budgeted hours are summarized below and in the following table:

 Layout – under this task HRC will stake the parking lot and trails one time. Should the contractor damage the staking or require additional staking due to sequencing or operations, we will seek compensation from the contractor to pay for these costs. However, the City would compensate HRC for this work then deduct or negotiate these costs from the contractor.

Estimated Hours = 8

2. Materials Sampling – under this task HRC will obtain field samples and perform materials testing on utility backfill, aggregate base, asphalt and concrete using our in-house laboratory.

Estimated Hours = 68

3. Observation and Field Engineering – under this task HRC will provide on-site field engineer(s) to monitor the Contractors work. Our observer will handle quantity verification at the end of each work day and prepare daily reports.

Estimated Hours = 160

4. Contract Administration – under this task HRC will provide bi-weekly pay estimates. Meetings and weekly progress reports are included, as needed.

Estimated Hours = 20
