SUBJECT: Tienken Road Selective Resurfacing Project (Adams Road to Livernois Road)

REQUEST:

The Department of Public Services requests that City Council award a contract for the Tienken Road Selective Resurfacing Project from Adams Road to Livernois Road to Pro-Line Asphalt in the amount of \$88,803.00 and authorizes the Mayor to execute a contract on behalf of the City.

The Department of Public Services also requests that City Council authorize a 10% contingency in the amount of \$8,880.30 for a total not-to-exceed construction cost budget of \$97,683.30.

REASON FOR PURCHASE:

Rochester Hills received four (4) sealed bids for the Tienken Road Selective Resurfacing Project (Adams Road to Livernois Road) on October 1, 2013 (bid summary attached). Of the bids received, Pro-Line Asphalt was the lowest, responsive, responsible bidder.

The proposed work includes milling and resurfacing the existing HMA pavement that extends over the concrete gutter to provide a uniform pavement edge along the gutter at the bookends of each location. Work will commence in October, 2013 with a final completion date of November 15, 2013. Work is required to be performed on weekends between 7PM Friday and 6AM Monday.

BUDGET:

It is proposed to utilize funding remaining from the Livernois @ Walton Concrete Repair Tri-Party project. The Livernois Road Repair project is included in the 2013 Budget with a \$316,000 project budget. With that project now completed, final project costs are anticipated to be approximately \$230,628.20 – leaving an additional \$85,371.80 remaining in the 2013 Tri-Party road project budget. If approved by City Council, Fiscal shall bring forth the appropriate 4th Quarter Budget Amendment.
