SUBJECT: DTE Energy Street Light Agreement for Tienken Road at Grandview Drive

REQUEST:

The Department of Public Services requests City Council to approve the Standard Agreement for Municipal Street Lighting (Agreement) between the City of Rochester Hills (Customer) and the Detroit Edison Company (Company) for the installation of one (1) community roadway light at the intersection of Tienken and Grandview and further authorizes the Mayor to execute the Agreement on behalf of the City.

REASON FOR PURCHASE:

This light and pole are being installed as part of a utility pole relocation project. The new facilities will maintain the level of public lighting for night visibility for vehicular and pedestrian traffic at this intersection.

The work consists of installing one (1) new 28.5 metal post supporting (1) 136W LED light located on the northwest corner of Tienken at Grandview. There are no installation costs to the City for this project. The current operating cost is \$284.16 billed at \$23.68 per month. The new operating cost will be \$330.48 annually billed at \$27.54 per month. Total annual budget increase is \$46.32, billed at \$3.86 per month. This increase is due to the change from an overhead light to an underground feed. This decision was made to improve consistency around the City as well as eliminate unnecessary wood poles required by an overhead light.
