ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE TO AMEND SECTION 54-531 AND REPEAL SECTION 54-532 OF ARTICLE X, SOLID WASTE, OF CHAPTER 54, FEES, OF THE CODE OF ORDINANCES OF THE CITY OF ROCHESTER HILLS, OAKLAND COUNTY, MICHIGAN, TO MODIFY SOLID WASTE TRANSPORTING UNIT LICENSE FEES, REPEAL CONFLICTING ORDINANCES, AND PRESCRIBE A PENALTY FOR VIOLATIONS.

THE CITY OF ROCHESTER HILLS ORDAINS:

Section 1. Section 54-531 of Chapter 54 of the Code of Ordinances shall be amended, as follows:

**Sec. 54-531. Commercial and residential refuse control.**

The license fees for commercial and residential ~~refuse~~solid waste transporting units, as provided in section 86-~~5864~~, shall be as follows:

- (1) First ~~refuse~~solid waste transporting unit ..... \$ ~~100.00~~150.00
- (2) Each additional unit ..... ~~20.00~~40.00

Section 2. Section 54-532 of Chapter 54 of the Code of Ordinances is repealed.

Section 3. Penalty. All violations of this ordinance shall be misdemeanors and upon conviction thereof shall be punishable by a sentence of not more than ninety (90) days of confinement to jail or by a fine of not more than \$500, or both, in the court’s discretion.

Section 4. Severability. This ordinance and each article, section, subsection, paragraph, subparagraph, part, provision, sentence, word and portion thereof are hereby declared to be severable, and if they or any of them are declared to be invalid or unenforceable for any reason by a court of competent jurisdiction, it is hereby provided that the remainder of this ordinance shall not be affected thereby.

Section 5. Repeal, Effective Date, Adoption.

(1) Repeal. All regulatory provisions contained in other City ordinances, which are inconsistent with the provisions of this ordinance, are hereby repealed.

(2) Effective Date. This ordinance shall become effective on \_\_\_\_\_, 2009, following its publication in the *Rochester Eccentric* on \_\_\_\_\_, 2009.
